Hearing loss is a type of deafness recognised as an **occupational disease**. It is included in table n° 42 of occupational diseases of Decree n° 63-405 of 10/04/1963, updated 25/09/2003. It is diagnosed by an audiometry showing, on the best ear, **a deficit of at least 35dB**, performed after cessation of noise exposure for at least 3 consecutive days. (INRS).
